## Inquiry into the Detention of People with Cognitive and Psychiatric Impairment in Australia

Liberty Victoria is one of Australia's leading human rights and civil liberties organisations. It is concerned with the protection and promotion of civil liberties throughout Australia. Liberty Victoria welcomes the opportunity to provide this submission to the Senate Standing Committee on Community Affairs into the indefinite detention of people with cognitive and psychiatric impairment in Australia (**this Inquiry**). Thank you for the extension of time granted to make this submission.

The legal apparatus that provides for a person with a cognitive disability to be detained, without review and on an indefinite basis, is concerning. The right to liberty, and the associated right to humane treatment while being deprived of liberty, are core tenets of Liberty Victoria<sup>1</sup> and are also enshrined under international human rights law.<sup>2</sup>

Any decision to restrict the liberty of a person should comply with standards provided in the Convention on the Rights of Persons with Disabilities to ensure procedural fairness, such as including specific and reviewable timeframes to terms of detention.
